GET READY FOR REPORTS - Not too long from now the National Commandant is going to ask for Detachment Reports. Please find it in the Marine Corps League Library under Program Documents. Please send a copy to me as well as National HQ. Also due are reports for VAVS and Scouting, which are on the Department website under programs. Toys for Tots reports, too! There are likely several I didn't mention, but they are coming up also. For most Detachments, the deadline for your 990 filing has passed. Please send copies to National & Department HQs. And your PLM Audit is due 31 December - including your Detachment's banking information for the direct deposit of payments.

I encourage every Detachment to make the necessary arrangements to send at least one representative to our winter meetings. We are at a new (for us) venue – the Penn Harris in Camp Hill. This facility will also host the Department Convention in June. The deadline for room reservations is December 31 (please don't wait until the last minute). The anticipated meeting schedule is included in this issue and will be coming to you by snail-mail but keep in mind that changes are possible. 1

Among those joining us in January is a representative of HOMECOMING 250. That is an effort to bring the 250<sup>th</sup> Anniversary celebrations of the US Navy and the US Marine Corps to Pennsylvania. This is a big deal, and you will want to be a part of it.



Uniforms - MCL Casual Dress

The Marine Corps League (MCL) Casual Dress uniform is comprised of the appropriate MCL cover, red blazer with two (2) MCL large gold buttons on front and three (3) or four (4) small MCL gold buttons on each sleeve cuff. The MCL blazer crest is worn, centered on the left chest pocket. A plain, white, standard-collar, button-front shirt is worn, tucked-in, with no collar emblems. A standard black tie shall be worn with a MCL tie clasp or a USMC enlisted tie clasp; tie clasp to be flush on each side of the tie. Female members may wear the applicable black neck tab. Black trousers are worn with a black belt, black socks, and highly-polished, black, plain-toe shoes. Female members may wear a black, straight-line skirt extending no more than two (2) inches below the knee, black or flesh colored nylons, and black, plain-toe, closed-toe, two (2) inch pumps.

The wearing of the blazer crest is optional. The metallic embroidered MCL blazer crest has clutch pins on the reverse and pins directly to the red blazer pocket, or may be worn on a plastic pocket sleeve, either glued or pinned to the plastic sleeve. The commercially sold pocket crest, with USMC emblem, MCL emblem, MCL seal permanently set into the plastic sleeve, or embroidered MCL crest that is permanently embroidered on the pocket of the red blazer itself.

Medals and Medallions:

The wearing of medals and medallions is optional. MCL members may wear up to three (3) large medals, (either DoD issued or MCL awarded). Medals shall be assembled on a single ribbon bar and placed centered, above the left chest pocket, medals are not to extend below the pocket edge. The Marine of the Year (MOY) medallion (National, Division, Department, or Detachment), the Chapel of Four Chaplains (Legion of Merit, Humanitarian Award, or Bronze Medallion Award), or the Military Order of Devil Dogs (MODD) collar, if authorized, may be worn with this uniform. Only one of these medallions may be worn at a time, at the option of the wearer. It is customary to tuck the medallion ribbon under the collar. Lapel Pins:

The wearing of lapel pins is optional. The following roster of lapel pins are authorized for wear on the MCL Casual Uniform:

- 1. Past National Commandant Pin
- 2. National Marine of the Year Pin
- 3. Devil Dog of the Year Pin
- 4. Past Department or Past Detachment Commandant Pin
- 5. Chapel of Four Chaplains Pin
- 6. MCL Membership Pin
- 7. Retired Marine or Retired Navy Pin
- 8. Life Member Pin
- 9. Ordained Ministers or Chaplains Symbol Pin
- 10. United States Flag Pin (3/8" X 3/4" in size)
- 11. Vietnam War 50th Commemorative Pin
- 12. Gold Star (family member) Pin

No more than two (2) lapel pins may be worn at any time. The priority placement (if wearing two (2) pins, is as follows: The Past National Commandant pin may be worn inboard with the National MOY outboard. National MOY may be worn inboard with a Past Department or Detachment Commandant pin, (only one(1) past commandant pin shall be worn). MODD Kennel Devil Dog of the Year pin may be worn outboard of the National MOY. The Chapel of Four Chaplains, MCL Membership, Retired Marine, or Retired Navy lapel pins may also be worn. Although there are several types of MCL membership pins (i.e. Past Commandant, Life Member, Five-year membership, Ten-year membership, etc.), only one (1) MCL membership pin shall be worn. One (1) miniature ribbon pin of the individual's choice may be worn above the lapel pin(s).

The US / USMC crossed flag pin is not to be worn with this uniform configuration.

Miniature Medals:

Miniature medals are never worn with this uniform configuration.

Ribbons and Badges:

Ribbons and badges are never worn with this uniform configuration.

Nametags:

Nametags are never worn with this uniform configuration.

Collar Emblems and Patches:

Collar emblems and shoulder patches are never worn with this uniform configuration.

Purchasing the Uniform:

The MCL Ship Store no longer stocks or maintains inventory of the red blazer. Members are encouraged to shop any clothing store for the applicable style and color, consistent with existing approved red blazer. However, the approved MCL red blazer shall have the proper MCL gold button affixed to the front and sleeve cuffs; these gold buttons are available from the MCL Ships Store.

The white, standard-collar, button-front shirt (male and female) may be purchased at any clothing store along with the black tie/neck tab, black trousers/skirt, black belt, black socks/nylons, black shoes/pumps. White, buttoned-collar shirt is never to be worn with this uniform configuration. Various forms of the black tie along with the black neck tab and the approved tie clasp may be purchased at the MCL Ships Store.

Bipartisan legislation that would support military members transitioning to civilian work was unanimously approved by the Pennsylvania House Professional Licensure Committee.

House Bill 1868 would increase the presence of veterans and military spouses on licensing boards and commissions, allow for military experience to translate to civilian licensure requirements and job qualifications, and expedite licensure renewals while waiving fees for veterans and spouses.

The bill was introduced by state Reps. Zach Mako, R-Lehigh/Northampton, Dave Hickernell, R-Lancaster/Dauphin, Jake Wheatley, D-Allegheny, Karen Boback, R-Lackawanna/Luzerne/Wyoming, and Chris Sainato, D-Lawrence.

"Pennsylvania's military men and women give some of their prime years to serving our country," Sainato said in a news release. "Unfortunately, many face challenges transitioning to civilian work – in part, because of licensing regulations that fail to account for military skills, training and experience. The process can prove challenging for military spouses, as well, because of frequent relocations."

The bill has been sent to the full House of Representatives for consideration.


