Paymaster Report:

Doug Forsythe presented the paymaster's report for April 2022. The General Smedley D. Butler Memorial Foundation Fund balance is \$7,847. Our twelve-month CD balance is \$48,257 and our business (checking) account balance is \$15,610. The last bingo brought in over \$500.

Ten names of members who have not paid dues in more than five years have been submitted to national for removal from our roster. Doug pointed that the detachment's electric bill has substantially decreased since the installation of LED lights by Sergeant-at-Arms Ken Weaver who did the work for without charge. The only cost to the detachment was the wholesale price of the lights. Emil Messikomer was also thanked for his work in installing shelving in the detachment.

A motion to accept the paymaster's report subject to audit was made by Gene Irvin and seconded by Jim Copeland; the motion passed.

Brandon Hardy Chester County Detachment 286. When the renaming is complete, a re-dedication will be held at the detachment to celebrate.
