Greetings to all the members of the Department of PA. Since my last message in July, I have been busy attending National Convention, Detachment meetings, Veteran Council meetings, and sadly funeral services for the spouse of a member. All of this while taking care of the day-to-day things that come with the role of Commandant. Here is an overview of what is going on:

At our National convention in Oklahoma City a new slate of National Officer's were voted in. Commandant Griffin, Sr Vice Morgan, and Jr Vice Miller were all unopposed so were voted in by unanimous vote. The office of Judge Advocate which had 4 candidates running was won by David Porter. It took three votes to determine a winner. Our own Bob Ziltz came in 2nd. A full listing of all of the Division Vice's can be found on the National website at www.mclnational.org.

There were 49 bylaw and Administrative Procedure changes proposed for this convention. Twenty-two (22) were approved, twenty-one (21) were rejected, and six (6) were withdrawn by the maker. I will leave it to the Judge Advocate to summarize those that passed, but I encourage all members to go to the National website under the convention tab and scroll down to read the changes for yourself. National is working to get the bylaws and Admin procedures updated, but in the meantime these new changes are in effect and must be followed. One of the changes affects delinquent members and the need for an application to reinstate dropped members.

There was a lot of other good information passed at convention, and I and other members of staff will be discussing it at the October meeting. A few of the topics were: there is a new Director of Events at Headquarters (National) to help take some tasks off Bob Borka's plate; they are looking into the feasibility of moving National Headquarters to Quantico to reduce costs; YPF program – used to have 1000 schools, now has about 10. They are working on a program to explain how to talk to schools to get them back involved. The 2025 convention will be in Grapevine, TX. Room rates are \$159 (for 2) with no parking fees. This is flat rate, NO additional taxes or fees.

The Department is once again helping to sponsor the Central PA Marine Associates Birthday Ball. As part of this sponsorship, the Department will have 16 tickets available on a first come first serve basis. The Ball will be on November 4 at the Penn Harris Hotel in Camp Hill with cocktails beginning at 4:30 PM (1630). More details will go out in a separate email.

The official date given for the Gate closure on Fischer Road at Indiantown Gap is 1 November 2023. We will have forms that we can fill out to make access smooth for our quarterly meetings and those members of staff who visit the post outside of meeting dates. The details will be given out at the October meeting and also conveyed in email.

My final note for this message is to make sure you send in your PLM audits and file your 990 tax returns. The PLM audits were mailed to each Detachment Paymaster in July. If your detachment did not receive that audit with their detachment roster, contact me. The deadline for National to receive it is 31 December. DO NOT wait until the last minute to send it. It must arrive at National PRIOR to that date. The deadline for 990 filings for all detachments on a 30 Jun fiscal year is 15 November. This should be for all detachments. If your detachment is still operating on a calendar year, you need to contact The Department Paymaster (Stephen Smalley) or myself so we can get that corrected.

Lt Gen. John R. Chaisson 1916-1972

In the summer of 1971, John Chaisson was mentioned twice in LIFE magazine as a potential successor to then Marine Commandant Leonard F. Chapman, Jr. True to character John Chaisson was largely dismissive of these comments. He was always realistic about the politics of Washington and specifically his standing with the Nixon White House.

He had joined the Marines in the autumn of 1940 when he was drafted out of law school. The Marines were his first choice because President Coolidge had spent the summer in Swampscott, Massachusetts, his home town. Coolidge had a Marine unit as his protection that summer. While at OCS, his unit



marched in FDR's third inauguration in 1941. By spring, 1966 he was a colonel serving as the G-3 for III MAF in South Vietnam, then commanded by Lt. General Lewis Walt. He often had VIP visitors and, in the picture attached, he is seen with the actor John Wayne in the middle and then Brigadier General Jonas Platt, the Chief of Staff III MAF during the summer of 1966.

The picture has a story to tell because Wayne always had one to share. Wayne had met with Ambassador Henry Cabot Lodge just before meeting with Chaisson and Platt. Lodge had a long record of public service. He

had served previously in the Army during WW II, U. S. Senator from Massachusetts, Ambassador to the United Nations 1953-1960, GOP nominee for Vice President in 1960. He served as our Ambassador to South Vietnam 1963-64 and 1965-67. In early 1964 he entered the New Hampshire primary to be the GOP nominee for president. He won the primary, beating Barry Goldwater whom Wayne had supported in the primary.

During his dinner with Chaisson and Platt, Wayne discussed his recent meeting with Lodge. He added that Lodge recalled the campaign as well. He said, "Lodge did not forget that I had been there working for Barry. He then told me that he understood he could easily get someone killed in Saigon for just \$20." Wayne added, "I do not think he was kidding" and laughed heartily.

Earlier in the spring, Chaisson encountered the "friendly" forces which were opposed to the central government and threatening more hostile action against it. These threatened hostilities pitted the U.S. Marines against the South Vietnamese forces threatening action against the government. On three occasions Chaisson had to intervene directly to stop hostilities from escalating further with attacks on American installations and harming U.S. forces. These encounters shaped Chaisson's view of the war. When asked, he would say it was an internal civil war among the "friendlies" within a larger civil war. (Cont. next page)

The internal civil war was between the SVN Army and the SVN Air Force and the larger civil war between the North Vietnamese and the South Vietnamese. These three encounters placed him between forces of the South where hostile actions were about to harm US Marine forces. The first encounter was reported in an article in TIME magazine on April 22, 1966. All three were described more completely in the Silver Star citation Chaisson subsequently received for preventing wider hostilities that could have devolved into major civil war among the "friendly" forces.

He wrote several times a week to his wife during the two and half years he was there. On one occasion, he told her that he and other Marines played volley ball with local Vietnamese citizens who appeared friendly. One night there was a guerilla raid that attempted to come through the lines. The next morning they found the body of one Vietnamese with whom they played volley ball. He commented that it was a strange war because it was often hard to know who the enemy was. Sometimes it was the friendly forces threatening civil war and other times it was the Viet Cong and North Vietnamese forces.

Later that year, Chaisson was promoted to brigadier general and was assigned as Director, Combat Operations Center, MACV in Saigon for the next 18 months. In this role there were many briefings of Washington officials and other VIPs traveling to Saigon. It was an assignment where there was a clear view of the total war and how complicated it was both in Vietnam and at home. When he left Vietnam in the Spring of 1968, he was skeptical that a clear victory was achievable. He served in various positions in Washington culminating in his assignment as Chief of Staff, HQ USMC.

In the autumn of 1971, I was assigned to Marine Barracks, 8th and I in Washington. That Christmas, Helen Twomey, the wife of the barracks Commanding Officer Colonel David Twomey, invited me to dinner to meet someone she thought I ought to know. My dinner partner was Jane Chaisson, the general's daughter. We married three years later. General Chaisson was correct. He would not be named CMC because he knew General Cushman was close to Nixon since he had been his aide when Nixon was Vice President. Chaisson had declined the same assignment and knew this would not be forgotten. Sadly. he died unexpectedly less than two months after his retirement in July 1972. He is buried at Arlington Cemetery near Justice Oliver Wendell Holmes, a fellow Harvard alumnus and native of Massachusetts. David Twomey (later Lt. General) was also a Swampscott native and buried nearby as well.

When I left the Marines in 1971, due to my injuries and belief that I could no longer serve the Marines and my country effectively, I thought what skills do I have that are transferable to civilian life.

After all, I was a combat Vietnam Marine (0311) and most of my skills did not actually make me a good applicant for many good jobs.

I felt as if my career opportunities were going to be limited as a disabled and MOS defined civilian.

I was so wrong! I went to college to not only earn a B.S., but also went on to achieve a M.A. All while working and with the support of a loving wife.

I quickly rose in the ranks of health care to very high-ranking positions of leadership, taught college courses in various majors including leadership, and had my own successful company which provided leadership and other principles to health care professionals, including doctors, nurses, construction management crews, etc.

How did this happen? Looking back, I realized that the Marines taught me much more than how to handle weapons and fight. They taught me perseverance, integrity, team work, work hard, belief in oneself, timeliness, ethics, adaptability, discipline, pride, problem-solving, motivation to succeed even when it does not seem likely and yes, leadership!

Today, I try hard to remember those principles and use them to encourage others to develop their own skills. Oftentimes, they, like me, did not realize how prepared we are to carry on after the Marines.

Why do so many Marines excel in civilian leadership roles? The answer is we were taught well while we served our nation!

As the saying goes, "once a Marine, always a Marine"!


