## **Standing and Program Committees Reports:**

 Commandant's Council - JVC Diamond- gave brief on this morning's meeting and thanked those for attending.



- PDC Council JRPC PDC Dave Brady NSTR. Commandant made official request for PDC Council to assist and take point in examining re-districting Dept. of PA. Issues with DVC detachment representation. Some districts have over 11 and some have less than 3 detachments.
- Marine of the Year President Victoria McCoy excused absence. Met at the end of lunch and selected Dept. of PA nominees. Submitting recommendations as required. Detachments start thinking about who to nominate and submit for Dept. Marine of the Year. Remember Associates to nominate as well.
- Convention Committee Acting Chair Victoria McCoy excused absence. Commandant Henry discussed 3 proposals for 2025 convention location. First hotel eliminated due to inadequate handicap accessibility. Second bid kitchen closed so inaccurate bid. One contender left, will be at Hilton in Scranton, PA. This will be 250th anniversary. Still in negotiations on room rates etc.
   Negotiated parking cost and got it waived. More information to follow in the next few weeks.
   Convention Committee approved dates for forms, will be mailed out and posted to the website.
- Budget Committee Chair JRVC Diamond met in the hospitality room, didn't see any big issues.
   One issue about trash dumpster charge being too high. Will investigate issue. Windows in bldg 396 will be repaired or looked at to be repaired. High cost on that bldg. Base maintenance tried to cover up broken windows.
- Audit Committee Chair JRVC Diamond submitted report to the Adjutant for records.
- Awards and Citations Chair SVC McCoy- not present.
- Training SVC McCoy Leadership training not present.
- Americanism Chris Shaw Sue Irvin not present.
- Scholarships Gene Irvin Commandant Henry asked for forms to be carefully reviewed and
  information entered correctly. Around 67 scholarship submissions and only around 28 awarded. The
  students did not send in last information stating they were attending school even after repeated
  attempts to get the right information.
- Samuel Nicholas Memorial Committee Doug Forsythe not present.
- Marksmanship Committee Jim Schreiber presented Awards for Rifle and Pistol matches. Refer to
  the document posted to the website if you want to see the Awards and standings. Get the message
  out to show up and shoot. Use social media to promote matches. 36 awards given out this year, so
  the program is growing. Looking to be creative with matches and make competitions fun. Match
  dates will be coordinated and published.
- Medical Assistance Committee Bonnie Shaw not present today. Report was submitted.
- Toys for Tots DVC VanZanardi not present today due to surgery on Tuesday. If participated in T4T and not an LCO who files to National, get After Action report to Dean VanZanardi.
- Scouting as of this week, a new Scouting Chair appointed Greg Slaegle. Look for him to appoint a committee and get scouting program back on track. Detachments not reporting to Dept. of PA their



scouting activities and Eagle Scout reports. National is asking for #s on Eagle Scout award handouts. Support Marine Sleagle moving forward.

• VVS -Marine Jacob Bertin stepped up and agreed to chair this committee and gave his report this morning. 8 checks distributed for 1st and 2nd quarter, out of 67 detachments.

Commandant Henry - asked for a motion to receive all Committee reports as presented. Motion by Paymaster Smalley and Second by DV 5 Anspach. Motion Carried.

# **Subordinate, Subsidiary and Independent Organization Reports:**

- MODD PA PACK did not meet due to weather. Pack Leader not present.
- Marine Corps League Auxiliary President Ruth Moyse not present, Auxiliary met via zoom.
- MCL of PA Foundation -President PDC Bob Ziltz. Foundation has same problems as the League-empty chairs, same people wearing multiple hats. Met with the Commandant and suggested the foundation funds used to help Marines in need, sitting on over half a million dollars. Have to follow mission. Took everyone off the list and starting from scratch. BOT approved new bylaws. In the past humanitarian assistance could only help Marines and not Associates, or help other 501c3 organizations. Now includes all members, Marine Veterans and their families. Look for Veteran shelter struggling in your community that needs Foundation funds. Foundation has 5 funds set up. BOT appointed more board members to the Foundation. Stay compliant with the law and get back to fundraising.

## **National Officer Reports:**

NEDIV VC - Mike Waluk - Housecleaning - TACOM Rifle reports due by end of year. DIV Conference in New Jersey this year April timeframe, look online for registration. If you can help support the Division please do so by taking an AD as this is only source of funding. Please attend if able. Department to submit nominees by 1 March for MoY and AoY. Was ready to step down as VC last year. Unwritten agreement between all 3 Divisions in the NE. NY stepped out for second time and caused a meeting with National BOT. NE DIV is unique and only one to do rotation. National BOT has to then make an appointment when rotation is off and someone steps out. Difficult time filling spots in any area of Detachment, Department and Division. Do we want to change the rotation process or keep using it? Each detachment and Department need to discuss this. In the process of putting an SOP together for Division. YPF - had BOT meeting a month ago - signed memorandum of understanding and accepted an SOP. Hitting a brick wall getting this program running. Scouting - got 2 of 3 departments moving. Detachments need to report Scouting certificates to Department and up. Use this as a recruiting tool. Charters- exhaust all means necessary to keep detachments afloatthen get the process moving rapidly to get those members transferred. Asking Commandant to keep him informed on detachments falling behind. 990s - complete and submit. We have the largest Div in the League. PLM- money for the detachment and department. Fill this out and submit. Make sure banking info is correct on PLMs. Scam emails - watch out for these. Asking who has downloaded MCL App. Encouraging members to use this App -uses Profile ID, not member ID. Newsletter - please participate. Looking for PA to receive award from National for Newsletter. Follow instructions on how to submit. Vacant positions in District - encourages members to step up and try these vacant positions. DV are liaisons directly to Dept. Commandants. 2024 - volatile year in politics. Charter prohibits us from any political affiliation while in MCL uniform. Be careful of politics on social media too.



## **Unfinished Business:**

  - Moving members from detachments must be current with dues. Black Diamond in process
    of turning in charter and transferring members. Tun Tavern detachment is struggling.
    Request for name change of a detachment is possible to keep their name. Cannot transfer
    any member not in good standing.
- Patriot cable was here this morning, updating wifi. Need someone with ethernet knowledge to "reterminate" wires. PDC Ziltz offered to do this.
- Updating software for Dept. computers still investigating which direction we want to take. There are many options.
- Revision of AP's- in process for Dept. of PA. Commandant and SVC working on these and will be ready by March meeting.
- YPF Will be clearing outdated material from Bldg. 3-96.
- Replace AED battery Cost will be between \$180-\$500. Depends on model of AED. More information coming in March.

- Pennsylvania War Veterans Council Marine Charles Trainor has agreed to stay on for reappointment to the Delaware Valley Veteran's Home.
- Attended State Veteran's Commission meeting last Friday. Conflicts with entry to post today. Will be back in touch with post police and Adjutant General's office to find correct procedure for March meeting.
- Robert E McHale from Detachment 1386 Leatherneck Square, asking for members that have children serving on active duty and if over the age of 18, they are eligible to become a member.
- Newsletter Editor Doug Graves discussed scam emails. Be aware and do not open suspicious emails.
- Greg Slaegle, Susquehanna detachment 308, discussed that MODD meets the same time as hospitality events. PACK can hold their growl when they choose per Commandant Henry.
- PDC Brady, website committee please check website for detachment information. Verify meeting time, place, Officers and Paymaster etc. Info is taken from ROI, will be updated upon receipt of supplemental report. Indiantown Gap National Cemetery volunteers collecting wreaths. In November took down the Avenue of Flags, 500 were designated for retirement. Need flags "internment" flags only that have been used for funerals. Do not burn internment flags, collect, separate them and bring to Dave Brady in a bin at the quarterly meeting. Cemetery is not gated. Information on the back table.

## Good of the League:

- Forms National and Department forms have been updated and sent out, including links. Make sure you are using updated forms. Most important is ROI, need name of Officer, Profile ID #, email address and phone number. Dues information changed at the bottom of form. What portion of dues does detachment keep. Department dues are \$5, most detachments are 2 or 5 dollars. Verify information on new forms. National is changing membership cards and removing member IDs and life member #s. Use Profile ID for MCL records. Listing detachment where voting rights are. No exact date on when cards are coming out.
- Ritual Book copies going around saying revised in 2021. Information inside that cover is not up to date. Any reference to Navy personnel, ritual book is outdated. MCL voted to allow regular membership to ALL FMF Navy personnel. Change to oath of membership- one oath for regular and



associate members. Ritual book still has both oaths listed. Shortened version in the library on the national website.

- Colyer James two applications on National library. Webmaster needs to fix website for incorrect application.
- Social media Florida detachment has page on facebook that links directly to MCL detachment
  website. National Public Relations Committee advised against posting this to a MCL page. Argument
  over personal page or detachment page. Two options Remove reference to the detachment or give
  up their charter. National has final say on what is acceptable to post on MCL pages. Proper response
  is to comply and acknowledge.
