#### **Unfinished Business**

- Closing Detachments JA Sofranko is absent. Commandant Henry briefed on the following:
  - Black Diamond #846 District 5 There are still members on the roster. Cannot close until all members have been transferred.
  - Juniata #687 (District 6) Members are being transferred but have not received official notice of the Detachment turning in their Charter. A message will go to D6VC Van Zanardi to check if they have any rifles.
- PA Foundation President PDC Bob Ziltz was appointed. New Bylaws have been submitted for endorsement. A motion to endorse the new PA Foundation Bylaws was made by D10VC Matt Popovich and seconded by Jr. PDC Brady. Motion carried.
- Gate Access The gates at Ft. Indiantown Gap are officially secured.
  - The Visitor Center and the guards at the gate apparently do not talk to each other. Some issues have come up about the lists not being at both locations.
  - You must enter your Social Security Number. If a person is only going to have their name on the list at the gate, then they do not need their Social Security number. For the year pass, the number does have to be entered. When it comes up on any computer screen, only x's appear instead of the number.
- IRS 990 Tax Return for FY 2023 (7-1-22 to 6-30-23) was approved and filed by the executives.
- Equipment A new color printer was purchased for Headquarters. The cost was \$296.79. Toner
  cartridges were also purchased at a reasonable price through Amazon. Currently looking into
  keeping the maintenance contract and fee on the black and white printer.

#### **New Business**

- The department will be introducing a SOP for a standard report for District Vice Commandants. The purpose is to offer guidance to help with reporting. It will contain the information the Department wants to see in the report. A request for a similar SOP be prepared for Detachment reporting.
- Forms for the convention will be posted and mailed to each Detachment in mid-February.
- In the budget, we have allocated \$1000 to be donated to the Pennsylvania Foundation and \$1000 to be donated to the National Foundation. A motion was made to deviate from the budget and take the \$1000 allocated to the Pennsylvania Foundation and redirect that to the National Foundation, specifically to their Scholarship Fund. Motion was made by Appointed D6VC Smalley and seconded by Jr. Vice Diamond. Motion carried.

- Commandant will authorize the bookkeeper to cut this check to the National Foundation. In the next six to eight weeks, the Commandant will be authorizing the bookkeeper to cut checks for the budgeted contributions to the National Cemeteries, Auxiliary, and some of the other donations the Department traditionally makes.
- Foundation President Bob Ziltz discussed appointments to the Foundation Board. Commandant appointed PNC Paul Hastings, PDC Tony Degregorio, and the Department Bookkeeper Cathy Kolakowski as Directors to the Foundation. A motion was made to approve the appointments as presented. Motion made by D10VC Matt Popovich and seconded by D3VC Colyer James. Motion carried.
- Northeast Division Vice Commandant Mike Waluk
  - TACOM rifles make sure we get those done by the close of the year
  - Division Conference April 12 and 13. Get people to come. \$115 per night is the reduced rate and with taxes and fees about \$138 a night. All personnel must be registered to attend.
  - ° Costs have gone up, but they have managed to keep the costs down. Commandant Henry stated that last year, the budget item for this donation was increased to \$300.
  - Scouting Need the mid-year numbers for Scouting.
  - Division MOY and AOY Nominations must be in by March 1
  - Issue that came up at National last year. Seems the rotation between the three states (NJ, NY, PA) is presenting issues. There needs to be a serious discussion between the Department Commandants about whether we keep this rotation or do away with it. This will have an effect on the Division from 2025 forward. The rationale from National is that you are never sure you are going to get the best qualified person through the rotation. However, voting does not always ensure that the best qualified person is elected. There will be a Division meeting that the Commandants will be invited to and this will be up for discussion. This will be prior to the Conference. Whatever is decided, there will be a SOP.
- ROI's being submitted, but website is incorrect. This is because the information on the ROI is wrong.

#### Correspondence

All correspondence received has been forwarded by email. All snail mail was junk or was forwarded.

#### Good of the League

- When corresponding, add the Department website. Commandant will revise the letterhead template. Please add the web address to your signature in emails.
- Social Media Take it seriously. There is a Detachment in Florida that is potentially losing their Charter over this. Inappropriate images on their page with a link to the Detachment website. When asked to remove either the pictures or the link to the website, the Detachment made a rude response.
- Political ads/endorsements cannot be on the Detachment Facebook page or website. You can put political statements on a personal page, but no pictures of you wearing MCL apparel.
- Recent email from National JA prohibiting Zoom for meetings. A question came up about how the National BOT is going to conduct business if they cannot hold their meetings by Zoom. NEDVC Waluk stated that you can hold a Zoom meeting with permission and the request goes up through the chain of command. There needs to be a discussion about extenuating circumstances.
