In accordance with Section 10020 of the Department of Pennsylvania Administrative Procedures the following amendment is proposed:

AMENDMENT TO CHAPTER FOUR SECTION 4010 ADMINISTRATIVE PROCEDURES OF THE DEPARTMENT OF PENNSYLVANIA.

CURRENT

SECTION 4010 – District Alignment. The Districts of the MCLPA shall be aligned in accordance with geographical location in the Commonwealth of Pennsylvania as outlined below.

- ~~(a) District One – Counties of Chester, Delaware and Philadelphia.~~
- ~~(b) District Two – Counties of Bucks and Montgomery.~~
- ~~(c) District Three – Counties of Berks, Carbon, Lehigh, Northampton and Schuylkill.~~
- ~~(d) District Four – Counties of Lackawanna, Luzerne, Monroe, Pike, Susquehanna, Wayne, and Wyoming.~~
- ~~(e) District Five – Counties of Bradford, Columbia, Lycoming, Montour, Northumberland, Snyder, Sullivan, Tioga and Union.~~
- ~~(f) District Six – Counties of Adams, Cumberland, Dauphin, Franklin, Juniata, Lebanon, Lancaster, Mifflin, Perry and York.~~
- ~~(g) District Seven – Counties of Bedford, Blair, Cambria, Fulton, Huntingdon and Somerset.~~
- ~~(h) District Eight – Counties of Cameron, Centre, Clearfield, Clinton, Elk, Indiana, Jefferson, McKean, Potter,~~
- ~~(i) District Nine – Counties of Clarion, Crawford, Erie, Forest, Mercer, Venango and Warren.~~
- ~~(j) District Ten – Counties of Armstrong, Allegheny, Beaver, Butler, Fayette, Greene, Lawrence, Washington and Westmoreland.~~

PROPOSED:

- (a) District One - Counties of Chester, Delaware and Philadelphia.
- (b) District Two - Counties of Bucks and Montgomery.
- (c) District Three - Counties of Berks, Carbon, Lebanon, Lehigh, Northampton and Schuylkill.
- (d) District Four - Counties of Lackawanna, Luzerne, Monroe, Pike, Susquehanna, Wayne, and Wyoming.
- (e) District Five - Counties of Bradford, Cameron, Clinton, Columbia, Elk, Lycoming, McKean, Montour, Northumberland, Potter, Snyder, Sullivan, Tioga and Union.
- (f) District Six - Counties of Adams, Cumberland, Dauphin, Franklin, Juniata, Lancaster, Mifflin, Perry and York.
- (g) District Seven - Counties of Bedford, Blair, Cambria, Centre, Clearfield, Fulton, Huntingdon, Indiana, Jefferson and Somerset.
- (h) District Eight - Counties of Armstrong, Allegheny, Beaver, Butler, Clarion, Crawford, Erie, Fayette, Forest, Greene, Lawrence, Mercer, Venango and Warren, Washington and Westmoreland.

RATIONALE: To more evenly distribute Detachments across the Districts to allow for more effective administrative functioning of all Districts.

EFFECTIVE DATE: This amendment would be effective upon adoption. Meaning that the District Vices elected on 22 June 2024 would be according to the new Districts outlined in the proposed realignment.
