To preserve the History and Traditions of the United States Marine Corps, we honor Major Samuel Nicholas as the Father & First Commandant of the Marine Corps.

Major Samuel Nicholas was buried in an unmarked Quaker burial ground in 1790. In 1997, the Friends Historical Library located at Swarthmore College documented Samuel Nicholas burial site at their historic cemetery, 4th and Arch streets Philadelphia, just blocks from Independence Hall.

In 2013, the Cpl Brandon Hardy Chester County Marine Corps League Detachment 286 of PA, obtained permission from the Society of Friends to place a burial marker at Major Nicholas's burial site. In 2015, a resolution was passed at the Marine Corps League National Convention requiring that the Father of the Marine Corps be honored on three occasions. In 2024, the dates for those occasions are the Sunday before Memorial Day (Sunday, May 26th, 2024), Independence Day

(Wednesday, July 3rd, 2024), and on the Marine Corps Birthday (Sunday, November 10th, 2024). Muster times are 1100 for Memorial Day and Independence Day at the Samuel Nicholas Memorial (Friends Meeting House at 4th and Arch Philadelphia, Pa). Muster times for the Marine Corps Birthday are 0930 mustering at 4th and Arch for the wreath laying and taps at Samuel Nicholas Memorial (Friends Meeting House at 4th and Arch).
