# **Standing Committee Reports**

• Commandant Henry and JVC Diamond - Budget and Audit Committee - budget is not looking good due to low sales on tickets and calendars. Will work at getting a better handle on this. Commandant wants to make time in upcoming meeting for members to look at the budget.



• PDC Ziltz - MCL of PA Foundation report - In the process of creating written policy documents. Currently working on a new website and new special email inbox. 2 items of business for the BOT to consider - appointment of Frank Kelly as a voting Director and working on a new website as webmaster and a bylaw change. Motion to approve Frank Kelly as Director made by D10 VC Popovich and second by D5 VC Anspach. Motion Carried. Motion to approve bylaw change - same problems as Department with getting people to attend meetings, so opened meeting up to zoom. Proposed a bylaw change to section 6.01 of the Foundation bylaws to assign meetings in the year. 3 word deletion in paragraph B of 6.01. Proposing to change wording to allow electronic meetings for the required 4 annual meetings. Paragraph C- Proposing to strike the specifics of "between January meetings" verbiage. Motion made by JVC Diamond and second by D2 VC Irvin to approve the Foundation bylaw changes as stated by PDC Ziltz. Motion carried.

#### **Unfinished Business:**

- Juniata was brought up by Commandant Henry to JA Sofranko they are on the cusp of voting to turn in their charter.
- Commandant Henry has closed a historic amount of Detachments in one year. Most that are closing
  have other Detachments near that members are transferring to. Advice given by JA Sofranko to DVC
  to transfer members to active detachments and not inactive detachments.
- Black Sheep may have to consider holding a meeting to vote to turn in their charter. JA Sofranko
  asked to speak to Detachment to force a turning in of their charter and not even wait for a vote to do
  so. Question was asked by D10 VC how long can non-compliance be tolerated before Department
  takes action? Commandant Henry willing to give a year of leniency before shutting down a
  Detachment. SVC McCoy did an excel compliance report of the active Detachments, only a small
  handful are perfectly compliant in ALL issues of compliance.
- Reminder from previous meeting reservations deadlines are posted for hotel reservations. No
  phone calls or double checks moving forward by the Commandant or SVC to ensure rooms are
  reserved. Reimbursement will only be for the contracted rate if you do not make your room
  reservations correctly or on time. If the hotel does not have knowledge of block codes or meetings
  then contact the Convention representative. Deadlines must be followed.

  support.
- Tun Tavern issue brought up by D1 VC Brown. Tun Tavern must complete the process of closing before any name change can take place.
