National Officer Reports:

Unfinished Business:

- PLM Audits 27 detachments do not have PLM audits on record at National. 6 Detachments admitted to sending theirs in late. Will be advocating for the 7 Detachments that definitely sent theirs in on time and in the correct way. PLM audits are not a suggestion, they are a requirement.

New Business:

- Report from Midwinter new member database portal. 18 proposals for bylaws and AP changes. Will be a chapter 9 update. V on member numbers to identify which associate members are also Veterans. Commandant will be asking each Detachment to go over rosters and identify associate Veteran members.
- Convention need members to start thinking about a proposal to have the 2027 convention in their area. Need to get back to the procedure of having location more than 12 months out.
- Convention 2025 Information is posted on the Dept. website. Dates are 26-29 June at Penn Harris Hotel in Camp Hill. JVC report on coin 80th Dept of PA anniversary and 250th USMC birthday. Will be selling this coin. Coins will sell for \$10, cost is \$4. Motion made by SVC McCoy for Department of PA to order 500 coins to be sold at \$10, and second by SAA Bob Sundling. Motion carried. JVC will send a color flier for Detachments to see the coins.
- Donations at the BOT meeting last evening we voted to make our special contributions donations. Some are based on correspondence received, some are historical. Commandant briefed the membership on the donation list.
- D1 VC Brown had a 50/50 at his District meeting and wants to give the \$100 winnings to PA Wounded Warriors.
- SVC McCoy Keystone HQ Det, Paymaster, created a Zelle account to allow electronic money payments. Would like

 Dept.
