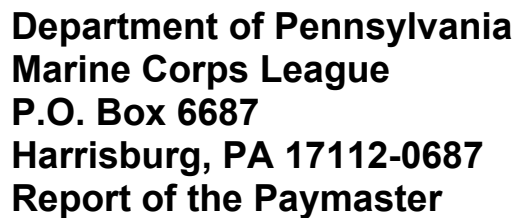

Report of the Paymaster**

Reporting Period – FY 2026 1st Quarter (1 July 2025 thru 1 Oct 2025)

- **Detachment PLM Distribution –**
 - The PLM Distributions have all been sent out to the Detachments.
 - We have received 20 PLM Audits in return.
- **Detachment Closings –**
 - Black Diamond Detachment has been listed as Inactive by National.
 - Juniata County is in the process of closing.
- **Detachment 990 Submissions –**
 - 17 Detachments have properly submitted their 990 Notices to the Department.
 - 59 Detachments are current, with 24 Detachments due by November 15, 2025.
- **Compliance Issues –**
 - Fiscal Year – National Bylaws require all Detachments and Departments to be 501c (4) exempt organizations and listed under Group 0955. As part of the group listing, each subordinate organization's fiscal year should match National's fiscal year of 1 July through 30 June.
 - 40 of 63 Detachments have the correct fiscal year (6).
 - 22 Detachments have a calendar fiscal year of 1 January through 31 December (12).
 - 1 Detachment has a fiscal year of 1 June through 31 May (5).
 - 1 Detachment has a fiscal year of 1 October through 30 September (9).
 - Membership –
 - There are 6 Detachments (290, 445, 660, 856, 1117, 1400) that currently have less than 15 Regular Members, which is required by National Bylaws. A Detachment must maintain at least 15 Regular Members in good standing.
 - IRS 990 Filings –
 - 1 Active Detachment is 1-year delinquent. 1 Closing Detachment is 1-year delinquent.
 - 1 Detachment is currently revoked. Reinstatement paperwork has been submitted.
 - ROI Issues –
 - 3 Detachments (295, 302, 412) have ROIs missing required Officers.
