Subject: 2025 Updated Notice of Death Procedure

Attention: Chaplains or Acting Officers

There is a new procedure to follow when filing NOD's. This change will affect all Department level Chaplains or the acting officers. This change is based on the revised 2025 MCL National Administrative Procedure, Section 7010.

1. Effective immediately Detachment Chaplains will be responsible for sending copies of the NOD's to the following:
 - a. Detachment Paymaster
 - b. Department Chaplain
 - c. Division Chaplain
 - d. National Chaplain
 - e. Marine Corps League National Headquarters Membership Manager
2. Detachment Chaplains will download and completely fill out the new NOD form on their computer. Access the new NOD form the MCL National library using the link below.
