**Reporting Period – FY 2026 2<sup>nd</sup> Quarter (1 Oct 2025 thru 6 Jan 2026)**

**• Detachment PLM Distribution –**

- The PLM Distributions have all been sent out to the Detachments.
- We have received 51 PLM Audits in return.

**• Detachment Closings –**

- Juniata County is in the process of closing.
- Standing Stone has started the process of closing.
- Lebanon County is in the process of closing.

**• Detachment 990 Submissions –**

- 8 Detachments have properly submitted their 990 Notices to the Department.
- 42 Detachments are current.
- 20 Detachments are delinquent.

**• Compliance Issues –**

- Fiscal Year – National Bylaws require all Detachments and Departments to be 501c (4) exempt organizations and listed under Group 0955. As part of the group listing, each subordinate organization's fiscal year should match National's fiscal year of 1 July through 30 June.
  - 40 of 63 Detachments have the correct fiscal year (6).
  - 22 Detachments have a calendar fiscal year of 1 January through 31 December (12).
  - 1 Detachment has a fiscal year of 1 June through 31 May (5).
  - 1 Detachment has a fiscal year of 1 October through 30 September (9).
- Membership –
  - There are 4 Detachments that currently have less than 15 Regular Members, which is required by National Bylaws. A Detachment must maintain at least 15 Regular Members in good standing.
- IRS 990 Filings –
  - 1 Detachment is currently revoked. Reinstatement paperwork has been submitted.
- ROI Issues –
  - 3 Detachments have ROIs missing required Officers.
  - 7 Detachments are 1-year delinquent in their ROI submission for FY25. Elections are to be held from 1 September through 15 May. ROI submissions are required to be submitted within 15 days of election to the Department Adjutant. They must be submitted to National no later than 30 June. Please submit your **Detachment** Report of Installation (ROI) to the Department **Adjutant**.

• **Transmittals –**

- One of the main focuses of the **Department Paymaster** is processing Transmittals.
- A few items I have taken notice of:
  - Oath not being signed on Semper Fi Magazine Applications. Required (automatic kickback)
  - The Type of Member, Membership, or Felony Question not answered. Required (automatic kickback)
  - Checks...I have had to call Morgan Stanley more than a few times to get checks that are barely legible pushed through. If your handwriting rivals a Dr's shorthand, please have someone else fill out the check and then sign it. Do not put 0.00 under the amount in the box. With mobile deposit the program has trouble reading the numbers clearly and it can be rejected. Dates are another issue. Please verify the correct date. If possible, please put the Transmittal number in the memo line.
